

**Multi-Market “The Metallica Life Burns Faster Flyaway”  
Official Contest Rules**

These rules apply to the “Multi-Market “**The Metallica Life Burns Faster Flyaway**” Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WRIF-FM, WCSX-FM, WRAT-FM, WDHA-FM, WMMR-FM, WMGK-FM, and WPEN-FM (each a “Station,” collectively the “Stations”). **In addition, the General Contest Rules posted at [www.wrif.com](http://www.wrif.com), [www.wcsx.com](http://www.wcsx.com), [www.wrat.com](http://www.wrat.com), [www.wdhafm.com](http://www.wdhafm.com), [www.wmmr.com](http://www.wmmr.com), [www.wmgk.com](http://www.wmgk.com), [www.975thefanatic.com](http://www.975thefanatic.com) apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

**1. HOW TO ENTER**

- a. The Contest will begin on Monday, March 2nd, 2026 and end on Sunday, March 29th, 2026.
- b. Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person during the Online Entry Period regardless of Station website used to enter and regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. There will be up to a total of one (1) Grand Prize winner selected in this multi-market Contest.

**2. ELIGIBILITY RESTRICTIONS**

- a. This Contest is open to all Station listeners who are 21 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in the following Michigan counties: Lenawee, Monroe, Wayne, Washtenaw, Jackson, Hillsdale, Ingham, Livingston, Oakland, Macomb, St. Clair, Lapeer, Genesee, and Shiawassee; the following Ohio Counties: Lucas, Fulton, and Williams; Delaware; Massachusetts; New Jersey; New Hampshire; Pennsylvania; or Rhode Island except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

### 3. PRIZES

- a. Up to one (1) Grand Prize will be awarded in the Contest. The Grand Prize is being provided by Live Nation and consists of the following prize assets:

Two (2) P2 Premium Reserved tickets for two (2) people (winner and one (1) guest) to attend Metallica: Life Burns Faster at Sphere in Las Vegas on October 1 and October 3, 2026 (two tickets per show; four total tickets). *Approximate value: \$1,800.00 USD*

One (1) three-night hotel stay (standard room, double occupancy) in the Las Vegas area for October 1 – October 4, 2026 (hotel to be selected by Live Nation). *Approximate value: \$600.00 USD*

Roundtrip coach airfare for two (2) from a major airport nearest the winner's residence within the United States to Las Vegas, NV departing on October 1, 2026 and returning October 4, 2026. *Approximate value: \$1,800.00 USD*

The winner and guest are responsible for all other expenses not specifically stated herein, including but not limited to ground transportation, baggage fees, meals, gratuities, incidental hotel charges, seat upgrades, travel insurance, and personal expenses.

**The Total Approximate Retail Value (“ARV”) of the Grand Prize is \$4,200.00.** The winner will be solely responsible for all federal, state, and local taxes and any other fees and expenses not expressly included in the prize description associated with the receipt and use of the prize.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, merchandise, souvenirs, local and long-distance telephone calls, gambling, spa and beauty services, the purchase of alcoholic or carbonated (soda) beverages, the purchase of upgraded paid dining options, shore excursions, any meet and greets with artists or other VIP events onboard (unless open to the public), VIP seating or check in, backstage or all access passes are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check-in to cover any incidental expenses incurred during the winner's stay. Winner and guest must abide by all airline, hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. Failure to claim Prize by the specified time will result in forfeiture of the prize. Up to one (1) multi-market Grand Prize winner will be selected at approximately 12:00 PM ET on Monday, March 30th, 2026 in a Station-conducted random drawing from all combined eligible online entries received during the Online Entry Period on each Station's website. Potential Grand Prize winner will be notified by phone and/or email promptly following the random drawing.
- b. Odds of winning the Grand Prize depend on the number of combined eligible online entries received during the Online Entry Period on each Station's website.
- c. Entrants need not listen to the Station or be present to win.
- d. Prize winner must confirm acceptance of prize within five (5) days of winning, or risk disqualification and selection of an alternate Prize winner (time permitting) in a random drawing of all remaining eligible online entries received.
- e. Decisions of Station management with respect to the Contest are final.
