

**DAVE & CHUCK THE FREAK'S "BITS THAT PAY" SECOND CHANCE CASH
CONTEST
OFFICIAL CONTEST RULES**

These rules apply to Dave & Chuck The Freak's Bits That Pay Second Chance Cash Contest ("Contest") conducted by Beasley Media Group, LLC d/b/a 101 WRIF ("Station"). **In addition, the General Contest Rules posted at www.wrif.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on Monday, October 28, 2024, and end on Friday, November 22, 2024.
- b. To enter, listen to the Station each weekday beginning on Monday, October 28, 2024, and end on Friday, November 22, 2024, between 12:15pm-12:30pm Eastern Time ("ET"), 2:15pm-2:30pm ET, 4:15pm-4:30pm ET, 6:15pm-6:30pm ET, and 8:15pm-8:30pm ET for the announcement of the Dave & Chuck "bit" (the "Phrase"). Once an entrant hears the Phrase, entrant may enter online as follows:
- c. To enter online, visit www.wrif.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on Monday, October 28, 2024, at 12:15pm ET and ending on Friday, November 22, 2024, at 11:59pm ET ("Online Entry Period"). **Entrants will be required to submit the Phrase and the date and time it was aired in order for each entry to be valid.** Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- d. **There will be up to five (5) unique Phrases announced each weekday during the Contest dates.**
- e. There will be up to a total of one (1) winner selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 21 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in the Detroit Metro Area, consisting of the following Michigan counties: Lenawee, Monroe, Wayne, Washtenaw, Jackson, Hillsdale, Ingham, Livingston, Oakland, Macomb, St. Clair, Lapeer, Genesee, and Shiawassee; and the following Ohio Counties: Lucas, Fulton, and Williams, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to one (1) Prize will be awarded. The Prize consists of One (1) Motley Crue 35th Anniversary Dr. Feelgood Box Set. ARV = \$139.94

a trip for one winner and one (1) guest (21 and older) to Las Vegas from April 10 to April 12, 2025, to attend Motley Crue's residency concert at Park MGM on April 11, 2025. Prize to include Round Trip airfare for Two (2) People from Detroit to Las Vegas, Two (2) Night Hotel Stay, and Two (2) tickets to Motley Crue's Residency show on April 11. Total Approximate Retail Value of the Prize is \$1,400.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long distance telephone calls are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. Winner and guest must be at least twenty-one (21) years of age. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. Winner and guest must abide by all airline, hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any flight. - c. Entrants must listen to the Station to acquire the Phrase to enter but need not be present to win.
- d. Winner must confirm acceptance of prize within five (5) days of winning, or risk disqualification and selection of an alternate winner (time permitting) in a random drawing of all remaining eligible entries.
